

Utica Boilers
*One Year Limited Warranty for Residential
Steam Boilers and Semi-Commercial and
Commercial Steam and Water Boilers*

(HEATING ONLY)
Effective June 1, 1979

Utica Boilers warrants that its cast iron boilers listed above are free from defects in materials and workmanship for one year from the date of installation. If any parts are found to be defective in manufacture, Utica Boilers will supply a replacement for the defective part(s).

This warranty is subject to the condition that the boiler must have been installed by a heating contractor whose principal occupation is the sale and installation of plumbing, heating and/or air conditioning equipment.

This warranty does not cover:

1. Components that are part of the heating system but were not furnished by Utica Boilers as a part of the boiler.
2. The workmanship of any installer of Utica Boilers's cast iron boilers. In addition, this warranty does not assume any liability of any nature for unsatisfactory performance caused by improper installation.
3. Any costs for labor for removal and reinstallation of the alleged defective part, transportation to Utica Boilers if necessary, and any other materials necessary to perform the exchange.
4. Improper burner adjustments, control settings, care or maintenance. Information is included in the Installation Instructions, Start-Up, Service and Maintenance Instructions, and other printed technical material furnished by Utica Boilers with the boiler.

This warranty does not extend to anyone except the first purchaser at retail and only when the boiler is in the original installation site.

IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE AND MERCHANTABILITY SHALL BE LIMITED TO THE DURATION OF THE EXPRESS WARRANTY. UTICA BOILERS EXPRESSLY DISCLAIMS AND EXCLUDES ANY LIABILITY FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY.

Some states do not allow the exclusion or limitation of incidental or consequential damages, or limitations on how long an implied warranty lasts, so the above limitations and exclusions may not apply to you.

For prompt warranty service, notify the installer who, in turn, will notify the Utica Boilers distributor from whom he purchased the boiler. If this action does not result in warranty service, contact Utica Boilers, Customer Service Department, 2201 Dwyer Avenue, Utica, New York 13501 with details in support of the warranty claim. Alleged defective part or parts must be returned through trade channels in accordance with the Utica Boilers procedure currently in force for handling returned goods for the purpose of inspection to determine cause of failure. Utica Boilers will furnish the new part(s) to an authorized Utica Boilers distributor who, in turn, will furnish the part(s) to the heating contractor who installed the boiler.
