

LENNOX QUALITY CARE PROGRAM EQUIPMENT LIMITED WARRANTY

APPLIES IN U.S.A. AND CANADA ONLY

FAILURE TO MAINTAIN YOUR EQUIPMENT WILL VOID THIS WARRANTY.

COVERED EQUIPMENT

The following Lennox equipment is covered by the Limited Warranty:

Gas-Fired Water Boilers: GWB8.

Oil-Fired Water Boilers: COWB.

Gas-Fired Steam Boilers: GSB8.

ONE (1) YEAR COVERAGE

The covered equipment and covered components are warranted by Lennox for a period of one (1) year from the *date of the original unit installation*, when installed in all applications. If, during this period, a covered component fails because of a manufacturing defect, Lennox will provide a free replacement part to the owner through an independent Lennox dealer or other licensed service contractor. You must pay shipping charges and all other costs of warranty service.

EXTENDED COVERAGE

Your Lennox limited warranty provides extended coverage on the components outlined below. The extended warranty coverage begins with the *date of the original unit installation* and represents the total warranty period for the specific component.

Heat Exchangers: GWB8, COWB -- Twenty (20) years
(residential applications only).

GSB8 -- Twelve (12) years
(residential applications only).

Warranty extensions to all other components furnished by Lennox, but purchased from other manufacturers, shall be limited to manufacturer's warranty, if any.

NOTE - If the date of original installation cannot be verified, the warranty period will be deemed to begin six (6) months after the date of manufacture.

COMPONENT AVAILABILITY

In the event that a component covered by this warranty is no longer available, Lennox will, at its option, provide a free suitable substitute component or allow the owner to purchase an equivalent new Lennox unit at a reduced price of 20 percent of the Lennox list price in effect on the date of the failure. Replacement equipment must be purchased through and installed by an independent Lennox dealer listed at www.lennox.com. The owner must pay shipping charges and all other costs of warranty service.

EXCLUDED COMPONENTS

The following components are not protected by the warranty: cabinets and cabinet pieces.

REPAIRS

All repairs of covered components must be made with authorized service parts by a licensed professional service dealer or contractor.

CARE OF EQUIPMENT

This new Lennox unit must be properly installed, operated and maintained by a licensed professional installer (or equivalent) or service agency in accordance with the unit installation, operation and maintenance instructions provided with each Lennox unit. Failure to provide maintenance per Lennox instructions will void this warranty. The owner may be asked to provide written documentation of annual and other periodic preventive maintenance. This warranty similarly does not apply to, nor is any warranty offered by Lennox for, any unit ordered over the internet, by telephone, or other electronic means unless the dealer selling the unit over the internet, by telephone or other electronic means is also the installing contractor for the unit.

WARRANTY PROCEDURE

When warranty parts are required:

- 1 - Be prepared to furnish the following information:
 - a - Complete model and serial number.
 - b - Proof of required periodic maintenance, installation date and location.
 - c - An accurate description of the problem.
- 2 - Call your local Lennox dealer or contractor.
- 3 - If the installing dealer is unable to provide warranty parts, check the yellow pages for another Lennox dealer in your area. Refer to the Lennox Industries Inc. website at www.lennox.com to locate a dealer in your area, or contact:

WARRANTY LIMITATIONS

- 1 - Lennox will not pay labor involved in diagnostic calls, or in removing, repairing, servicing, or replacing parts. Such costs may be covered by a separate warranty provided by the installing contractor.
- 2 - This warranty is void if the covered equipment is removed from the original installation site.
- 3 - This warranty does not cover damage or defect resulting from:
 - a - Flood, wind, fire, lightning, mold, or installation and operation in a corrosive atmosphere, or otherwise in contact with corrosive materials (chlorine, fluorine, salt, recycled waste water, urine, fertilizers, or other damaging substances or chemicals).
 - b - Damage to any product as a result of being improperly serviced or operated with insufficient water; allowed to freeze; subjected to flood conditions; or operated with water conditions and / or fuels or additives which cause unusual deposits or corrosion in or on the cast-iron sections.
 - c - Accident, or neglect or unreasonable use or operation of the equipment, including operation of electrical equipment at voltages other than the range specified on the unit nameplate (includes damages caused by brownouts).

- d - Modification, change or alteration of the equipment, except as directed in writing by Lennox.
- e - Damage to any product due to improper burner adjustments, control settings, care or maintenance.
- f - Parts, such as plumbing and wiring, not integral to the product.
- g - Boilers not installed by a qualified heating contractor.
- h - Boilers used in any application other than residential heating.

The installation of replacement parts under the terms of this warranty does not extend the original warranty period.

Lennox makes no express warranties other than the warranty specified above. All implied warranties, including the implied warranties of merchantability and fitness for a particular purpose, are excluded to the extent legally permissible. Should such exclusion or limitation of the warranty be unenforceable, such implied warranties are in any event limited to a period of one (1) year. Liability for incidental and consequential damages is excluded. Some states do not allow limitations on the duration of an implied warranty or the exclusion or limitation of incidental or consequential damages, so the limitations or exclusions may not apply to you.

Lennox will not pay electricity or fuel costs, or increases in electricity or fuel costs, for any reason whatsoever, including additional or unusual use of supplemental electric heat. This warranty does not cover lodging expenses.

Lennox shall not be liable for any default or delay in performance under this warranty caused by any contingency beyond its control.

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
