ECR is pleased to announce our 2017 Preseason Buy Up Program. Qualifying orders must be placed with ECR no earlier than May 1 and no later than May 26. The program also offers an early-bird incentive for orders received by May 12. For participating distributors, other ECR products may be ordered under this program and enjoy the favorable shipping and payment terms.

In conjunction with this year's Preseason Program we are announcing several new products and product enhancements.

#### DUNKIRK:

- ECR is pleased to announce the Dunkirk **DMG-240** and **DMG-380** 95% efficient heat-only condensing gas boiler with Labor Saver primary/secondary manifold. Please see accompanying literature and Dunkirk Trade Price Addendum.
- All **DCB/DCC** boilers ordered after May 1st, 2017 will include our new Labor Saver primary/secondary manifold.
- All **DXL and WPSB** boilers ordered with Taco pump will now feature the new Taco 007e ECM circulator as standard. Due to the change to the 007e, the DXL with Taco SKU will change, as shown on the Dunkirk Boiler pricing addendum. You will notice the price is unchanged for the DXL with Taco from the current Trade Price Book – 816. This offers a great value to our customers and will further differentiate the DXL for our competition. Grundfos and less pump derivatives with remain unchanged. The 007e will be expanded into other models as a rolling change throughout the year with full implementation by Q1 2018.

#### PENNCO

- The Pennco **15B** will now feature a factory installed and wired Low Water Cut Off. The 15B will also feature new aesthetics. New SKUs can be found in the Pennco Trade Price addendums. There will be a 2% price increase for the 15B product. All other Pennco models remain unchanged. Older models of the 15B are available at current pricing, while supplies last.

#### OLSEN

- The recently released **LRF** low boy oil furnace is available for shipment. Pricing can be found in the Olsen Trade Price Addendum.

Although some SKUs have changed, pricing has stayed as per the current Trade Price Book 816 with the exception of the 15B. Please take advantage of this preseason program as we will be having a normal price increase that will go into effect in August. Information will be sent to you in July regarding the August price increase.

### Purchase Order Requirements:

1. The Preseason Program is valid for orders placed with ECR no earlier than **May 1** and **no later than May 26, 2017**.
2. All Scheduled ship dates will be strictly enforced and any changes could result in the cancelation of the free goods incentive. If warehouse space restrictions exist, speak to your ECR Regional Sales Manager about Bill & Hold options.
3. Early Order Bonus – to earn the extra percentage amount in free goods each order, no matter of release date, must be received by close of business **May 12, 2017** No Exceptions Will Be Allowed.
4. Special Quotes or other programs do not qualify for the Preseason Program.
5. Equipment for multiple releases must be on separate purchase orders of equal value and include the shipment dates within the time allotment for each order per the schedule above when placing the order.
6. Free Equipment cannot be counted towards achieving a preseason order amount level.
7. Distributor must place all orders at the same time to qualify for any incentive level. Free goods must be specified and shipped on the last release and within the time schedule above or be forfeited.
8. Distributor shall specify models of Free Goods, up to the value specified for each incentive level. If the Free Good requested exceeds the Free Goods Allowance earned the difference will be charged to the distributor. Free goods will only be shipped with the last purchase order release.

### Combined Heating Equipment Preseason Terms

1. The Preseason Program is valid for orders received by ECR no earlier than May 1 and no later than May 26, 2017.
2. Freight is prepaid on all qualified orders to a single destination (in lieu of any freight allowance). ECR will coordinate product shipment points as needed to support manufacturing schedules.
3. Credit rating must be in good standing. All orders are subject to credit approval.
4. Discount dates will be strictly enforced.

Note: All brands are not available in all markets. Please contact your ECR Regional Sales Manager regarding the availability of brands other than those you are currently purchasing from ECR.

### Purchase Order Requirements:

1. Distributor must place all orders at the same time to qualify for any incentive level. Free goods must be specified and shipped on the last release and within the time schedule above or be forfeited.

3. Freight: F.O.B. Utica, NY – Cost of Ground Freight Included.

*Argo Brand purchases can be counted towards the heating equipment incentive levels (part 1) but will follow the terms of Part 1, (i.e. free product and terms). Argo products added to heating equipment incentive will not receive the terms specified above as a stand-alone program.*

### Preseason Terms:

1. The Preseason Program is valid for orders received by ECR no earlier than **May 1, 2017, and no later than May 26, 2017.**
2. Scheduled ship dates will be strictly enforced and any changes could result in the cancellation of the scheduled release.
3. Freight is prepaid on all qualified orders to a single destination (in lieu of any freight allowance). ECR will coordinate product shipment points as needed to support manufacturing schedules.
4. Credit rating must be in good standing. All orders are subject to credit approval.
5. Cash discount dates will be strictly enforced.
